# Part A: Pupil premium strategy plan

## Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support for individual and small groups of pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

- ensure disadvantaged pupils are challenged in the work that they're set
- act early to intervene at the point need is identified
- adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve.

## Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

1	Our assessments, observations and discussions with pupils and families have identified social and emotional issues for many pupils, notably due to a lack of social opportunities and changed routines as a result of the COVID-19 pandemic.

2	Our assessments, observations and discussions indicate that many of our disadvantaged pupils have not developed reading behaviours where they access texts for pleasure and a wide range of purposes.

## Part B: Review of the previous academic year

### Outcomes for disadvantaged pupils

Review December 2023:

The school has adopted Little Wandle as their phonics scheme from September 2023. This has built on what was already good phonics teaching, to make it an area of excellence in the school. Outcomes after the Autumn term show accelerated progress for 80% of children. Where children are making slower progress this is identified rapidly, children then access 'Keep Up' sessions allowing them to keep on track with their peers. Children and parents speak positively about the rich, inviting resources and how it motivates reading.

The library space has been renovated and new books purchased matching the children's interests and levels of development. The library is given high status with timetabled sessions and children choosing a book for pleasure to take home weekly. Teachers regularly read high quality texts to their class. Children are able to use their developing 'text talk' when discussing what they read, show an increase in known vocabulary and have well established independent reading skills.

Pupils who are identified as requiring SEMH intervention are able to access this on a weekly basis. This work provides the child/ren with strategies to enable them to manage their emotions and engage successfully in their classroom learning.

100% of disadvantaged pupils met the expected standard for their year group at the end of 2022-23.
