Part A: Pupil premium strategy plan

Statement of intent

Our intention is that all pupils, irrespective of their background or the challenges they face, make good progress and achieve high attainment across all subject areas. The focus of our pupil premium strategy is to support disadvantaged pupils to achieve that goal, including progress for those who are already high attainers.

We will consider the challenges faced by vulnerable pupils, such as those who have a social worker and young carers. The activity we have outlined in this statement is also intended to support their needs, regardless of whether they are disadvantaged or not.

High-quality teaching is at the heart of our approach, with a focus on areas in which disadvantaged pupils require the most support. This is proven to have the greatest impact on closing the disadvantage attainment gap and at the same time will benefit the non-disadvantaged pupils in our school. Implicit in the intended outcomes detailed below, is the intention that non-disadvantaged pupils' attainment will be sustained and improved alongside progress for their disadvantaged peers.

Our strategy is also integral to wider school plans for education recovery, notably in its targeted support for individual and small groups of pupils.

Our approach will be responsive to common challenges and individual needs, rooted in robust diagnostic assessment, not assumptions about the impact of disadvantage. The approaches we have adopted complement each other to help pupils excel. To ensure they are effective we will:

ensure disadvantaged pupils are challenged in the work that they're set

act early to intervene at the point need is identified

• adopt a whole school approach in which all staff take responsibility for disadvantaged pupils' outcomes and raise expectations of what they can achieve.

Challenges

This details the key challenges to achievement that we have identified among our disadvantaged pupils.

Challenge number	Detail of challenge
1	Our assessments indicate that many of our disadvantaged pupils have specific gaps in learning in Maths, GPS and/or Reading. Without addressing these, they are unlikely to meet the standard they are capable of whether that is expected or higher standard.
2	Our assessments, observations and discussions indicate that spelling is a specific barrier for many of our disadvantaged pupils. If this is not addressed, then this will prevent their development in writing which could in turn act as a barrier to achievement in the wider curriculum.

Intended outcomes

Adapted teaching and interventions/therapies will be targeted to remove gaps in learning.	A rigorous analysis of summative assessment at question level will take place for all pupils at least termly. This data will be used to determine how lessons can be adapted and interventions/therapies will be delivered to address. Improvements in % of PP children achieving EXS and HS across reading, GPS and Maths.
Pupils spelling outcomes will improve. This will lead to higher outcomes in writing as well as the wider curriculum where writing is a tool for recording.	Teaching will ensure pupils access a high quality spelling curriculum. Where pupils have gaps in knowledge or a specific barrier, interventions/therapies will be delivered to address these. Improvements in % of PP children achieving EXS and HS in spelling.

Activity	Evidence that supports this approach	Challenge number(s) addressed
PiXL subscription to allow support QLA and provide targeted therapies to address gaps in learning.	Small group tuition approaches can support pupils to make effective progress by providing intensive, targeted academic support to those identified as having low prior attainment or at risk of falling behind. The approach allows the teacher to focus on the needs of a small number of learners and provide teaching that is closely matched to pupil understanding. Small group tuition offers an opportunity for greater levels of interaction and feedback compared to whole class teaching which can support pupils to overcome barriers to learning and increase their access to the curriculum.	1
Delivery and resourcing of Little Wandle Keep Up	Studies in England have shown that pupils eligible for free school meals typically receive similar or slightly greater benefit from phonics interventions and approaches. This is likely to be due to the explicit nature of the instruction and the intensive support provided. It is possible that some disadvantaged pupils may not develop phonological awareness at the same rate as other pupils, having been exposed to fewer words spoken and books read in the home. Targeted phonics interventions may therefore improve decoding skills more quickly for pupils who have experienced these barriers to learning. <u>EEF - Phonics</u>	2

Outcomes for disadvantaged pupils

2023-24 National Assessments

<u>EYFS</u>

- 75% of all pupils achieved GLD. 67.7% achieved GLD nationally.
- 100% of PP children achieved GLD.

Phonics Screening – Y1

- 87.5% of all pupils passed the phonics screening. 80% of pupils nationally passed the screening.
- There were no PP children in this cohort.

Phonics Screening – Y2 retake

- 100% of all pupils passed the phonics screening re-take.
- There were no PP children in this cohort.

Intended Outcome 2 - To achieve and sustain improved SEMH outcomes for all pupils in our school, particularly our disadvantaged pupils.

This has been a core area of focus for the last 3 years with resources targeted towards this, in particular support staff trained to deliver SEMH interventions. This has resulted in better engagement including improved academic progress for children who received this intervention. This trend has included PP children.

Intended Outcome 3 - All pupils, including those that are disadvantaged, have well established reading behaviours in particular reading for pleasure.

The school has heavily invested in the library with a wide range of new books being purchased. These were purchased through consultation with a specialist service and were matched to the interests of all children, with a particular focus on PP. In addition, a new reading curriculum was introduced in Sept 2023, with a reading spine based on rich, diverse literature. This ensures all children access these texts and gain a good understanding of them.
